Additional Information:

Please note that there are no requirements for attending the Becker CPA Review classes but there ARE requirements for becoming a CPA:

1. You must have a Bachelor's degree in Accounting/business discipline with accounting concentration or a Bachelor's degree with a Master's Degree in Business
2. To be certified, you must demonstrate completion of 150 hours of courses that have an emphasis on business and accounting
3. You must register on a state, (US), CPA website to be able to sit the exam e.g. Colorado
4. Only individuals with a Bachelor's degree and the accounting requirements need apply. Check <http://www.aicpa.org/> and <http://nasba.org> for more details.

Becker also makes a few suggestions for students to keep in mind:

5. Becker's suggested method of test-taking is sitting an exam immediately following study for that module. However, students may opt to take the entire review and sit all four exams after study is completed on all four modules. Exams are offered **in the US**, six days a week during all months EXCEPT March, June, September and December and students must have registered in advance to sit the exam. The months when the CPA exams are NOT offered are referred to as blackout months.
6. Please note that registration to sit a CPA exam may take 30-90 days so students are encouraged to visit the CPA website (<http://www.aicpa.org/>) and the National Association of Boards of Accountancy (<http://nasba.org>) to learn more about registering to sit a CPA exam.
